Before joining the AU Law School in 2011, Assoc. Prof. Pisawat had taught at the Thammasat Law School. She concurrently serves as the executive director of the Mekong Region Law Center (MRLC) (a semi-pro bono) - MRLC is a regional NGO. She is also a member of the Subcommittee on Reviewing and Proposing Amendment to Children Related Laws to Comply with the Standards Imposed by the Constitution and the Convention of Child Rights (the Majestic Group). In the past, she served as a member of: the Special Committees Considering the Copyright Bill (that was passed into the Copyright Act, B.E. 2537) (both Houses); and, the Committee on Coordination and Supervision of Anti-Human Trafficking Operation (pursuant to Section 22 of the Act on Prevention and Suppression of Trafficking in Persons, B.E. 2551 (2008)). She was also an associate-judge of the Central Intellectual Property and International Trade Court. Among the agencies that have kindly granted scholarships/fellowships to Assoc. 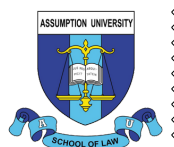
